Stated Meeting of Mission Presbytery

Presbytery Meeting Convened

The moderator, Rev. Peter Crouch, convened the meeting at 1:03 p.m. in the sanctuary with prayer. Peter welcomed Rev. Dr. David Gambrell (PMA), Rob Fohr (PMA), David Thompson (PCHAS), Rev. Al Kissling, Allison Harris (Mo Ranch), and Andy Watson (JKR) to the meeting. He also welcomed all the youth attending the presbytery meeting and first-time commissioners.

Welcome from Host Church

Rev. Brian Diebold brought greetings from Cross Roads Church.

Introduction of the Designated Offering: John Knox Ranch Scholarships

Andy Watson, Program Director for John Knox Ranch introduced the offering for camp scholarships to John Knox Ranch.

Omnibus Motion

The Stated Clerk **MOVED** to approve the docket as amended to include the Moral Witness Wednesday report after the Synod of the Sun report and the Committee on Representation and Participation following the Moral Witness report on Saturday. Second. **Motion approved.**

The Stated Clerk **moved** that Presbytery receive all reports as posted on the Mission Presbytery Pre-Presbytery Packet webpage, with the exception of the recommendations or motions annotated as requiring vote on the floor of Presbytery, and to approve the minutes of the March 2019 meeting as found on the webpage. Seconded. **Motion carried.**

Presbyterian Children's Homes and Services

President David Thompson brought greetings from PCHAS and shared information about the new capital improvement project at the San Antonio campus.

Mission, Justice and Outreach Committee (Report A)

RE Tom O'Meara, chair of MOJC gave the report. Tom reported on the work that congregations have done with asylum seekers and refugees. He encouraged the body to look at the ways that congregations can be involved in the work. He invited them to come to MOJC table and talk with them.

Order of the Day - Commission on Ministry (Report B)

Rev. Dan Fultz presented on behalf of the committee. He gave a brief tribute to the Rev. Dr. Ilene Dunn who had passed away in May. He called attention to the list of every church's COM liaison and encouraged elders and pastors to be in touch with their liaisons. He called on Rev. Monica Smith, chair of the COM Examinations Team. Monica presented Rick Carlson to be examined as a commissioned pastor. Monica asked Rick to answer the following question, "Give one example of how our Reformed theology is reflected in our polity." Joel Moody asked him in what he likes about the Calvin's view of the Eucharist.

Rev. Dan Fultz **moved** that Rick Carlson's examination be sustained and that he be approved by Mission Presbytery to serve as Commissioned Pastor at Goliad Presbyterian Church, Goliad. **Approved.**

Rev. Monica Smith presented Rev. Kristin Huffman who has transferred into Mission Presbytery as a member-at-large. She asked Kristin to share what she is doing and what she is excited about.

Worship

The Presbytery gathered again at 5:00 p.m. for worship. Rev. Nancy Benson-Nicol preached on Colossians 1:1-14. The service included the covenanting of the Vital Congregations churches led by Rev. David Gambrell. Rev. Brian Diebold and Rev. Dan Milford officiated at the Lord's Table.

The meeting recessed at 6:00 p.m. and will reconvene at 8:30 Saturday morning.

Morning Prayer

The meeting reconvened at 8:33 a.m. with morning prayer led by the Youth at Presbytery participants.

Youth Connection Committee (Report C)

Rev. Ellen Hensle and Rev. Katy Walters, co-chairs presented on behalf of the committee. The youth participating in the 2019 Youth Triennium were invited forward and commissioned for the event.

General Presbyter Report

Rev. Sallie Watson presented the report. She shared that every time she turned around she was reading, hearing and getting thank you notes about the people of Mission Presbytery. She thanked the group participating in Vital Congregations and reminded the body that congregations have until December to join the program. She introduced Ezquiel Herrera who will be the Commissioned Evangelist in the Rio Grande Valley. She introduced Rev. Rob Mueller and Rev. Krin Van Tatenhove's book, "Neighborhood Church", that is the General Assembly's national read for this year. She invited Rob to speak about the book. A short video about the book was shown.

General Council Report (Report D)

RE Judy Ferguson, Chair of General Council gave the report. She shared that the General Council is bring a letter to send to Rev. Dr. Herbert J. Nelson, Stated Clerk of the Office of General Assembly regarding his work around immigration (see Report D.3). The General Council **moves** that the mission approve the amended letter to be sent to Dr. Nelson. **Motion approved.**

The council **moves** that the presbytery approve an Administrative Commission to work with the Commissioned Evangelist in the Rio Grande Valley. The AC will be tasked with the following responsibilities:

- Assisting the NCD in discerning and implementing its identity and mission.
- Monitoring the NCD progress in doing its mission.
- Interpreting the mission of the NCD on a regular basis to the greater Church.
- Assisting the NCD leadership team/steering committee in training and assuming leadership that encompasses the duties and responsibilities of a Session of Elders in the PC(USA) according to G-3.02 of the Book of Order.
- Encouraging the NCD in establishing sound stewardship and giving practices.
- Assisting the NCD to establish sound accounting practices, including but not limited to: bookkeeping; budgeting; receiving and counting contributions; the establishment of checking accounts; on an appropriate scale for the requirements of the NCD.
- Assist the NCD in assembling all appropriate documents required by the Book of Order and the State of Texas and otherwise complying with the requirements of G-1.0201.
- Any duties that may be assigned by Presbytery, particularly where the AC is empowered as an Administrative Commission.

Motion carried.

Judy Ferguson invited Commissioned Pastor Ezequiel Herrera to come forward to be commissioned as the Commissioned Evangelist for the Rio Grande Valley. Rev. Peter Crouch asked the constitutional questions. RE Judy Ferguson led the commissioning prayer. Rev. Nancy Marroquin gave the charge. Rev. Peter Crouch gave the blessing.

Order of the Day - Break

Break was taken at 9:41 a.m. and the meeting reconvened at 10:09 a.m.

Stewardship and Fiscal Oversight Committee (Report E)

Rev. Scott Nowack and Rev. Kevin Jones reported on behalf of the committee. Rev. Kevin Jones presented Better Together Fund Grants of \$29,000 to the following:

- First Presbyterian Church, Kerrville, First Junction and Harper
- St. Andrews Presbyterian Church, Austin and Faith, Austin

Kevin announced there are five \$100 scholarships available for the Kaleidescope Stewardship Conference in San Diego.

Rev. Scott Nowack presented on behalf of the Fiscal Oversight Team. The audit firm of Achteley & Associates has been selected to perform the 2018 audit. John Knox Ranch is doing well and is able to pay for their permanent staff, Board of Pensions, and Zoom website. He explained that our deficit for 2019 is "not as bad as it looks". The $3^{\rm rd}$ quarter insurance payment has been made. The special offerings funds have been sent since the report. Shared mission support is greater this year-to-date than

last year. 75% of the congregations have paid the 2019 per capita. The committee strongly encourages the other 25% to submit per capita.

RE Karl Spinner spoke briefly about embezzlement that has been occurring at congregations in the presbytery. Fiscal Oversight Committees encourages all the congregation to examine their practices to ensure they are protection including separate duties, term limits for Treasurers, monthly financial statements to the session, do a "surprise" bank reconciliation two or three times a year, and an annual full financial review by people not related to the treasurer.

CP Kris Bair announced that the session of Alice had voted to double their giving to the presbytery in its last year.

Order of the Day – Committee on the Preparation for Ministry (Report F) Rev. Malcolm McQueen presented the report on behalf of the committee.

Rev. Malcolm McQueen **moved** that the following be enrolled as inquirers:

- Amy Myhand (Dripping Springs, Dripping Springs)

Motion carried.

Rev Malcolm McQueen **moved** that Mission Presbytery receive Rachael McConnell (Covenant, Austin) as a candidate for Ministry of the Word and Sacrament after examining her with respect to her Christian faith, forms of Christian service undertaken and motives for seeking the ministry. Rev. David McCann asked her to share how has her understanding of music formed her faith to seek the ministry. The question was called. Motion to cease the examination was approved. **Motion carried.**

Rev. Malcolm McQueen asked the constitutional questions and gave the charge to the candidate. Rev. Jim DeMent led the prayer.

Disaster Preparedness and Assistance Report

Ed Sackett, Disaster Recovery Coordinator for Mission Presbytery gave the report. He reported that the Disaster Preparedness Directorate has met and is working on the protocol for all aspects of preparedness. It will be available at the next presbytery meeting.

He updated the body on the work going on in Mission Presbytery and the Synod. Three presbyteries in the synod of teamed up to create a network (Mission, New Covenant, South Louisiana). We have received calls for assistance from other presbyteries and agencies throughout the nation. The shower unit is currently serving refugees in Las Cruces, NM.

Work on recovering from Hurricane Harvey will be ongoing for the next year.

He reported that the presbytery sent 1600 blankets to the border after Easter. He thanked First McAllen for their assistance in getting them distributed on both sides of the border. Another 1600 will be sent to the border and 400 will be distributed in San Antonio.

Education and Congregation Nurture Committee (Report G)

RE Sandy Pinaire, chair, presented on behalf of the committee. The committee is working with Presbytery staff to develop a closed Facebook group for educators. The committee is planning a retreat at John Knox Ranch. There are scholarships and grants available through the committee.

Pastoral Care Committee (Report H)

Rev. Mary Breden and Rev. Marsha Brown presented on behalf of the committee.

The committee has planned a retreat for pastoral leadership at Mo Ranch in

October. Rev. Dr. Whit Bodman will be the keynote.

Church Development and Evangelism Committee (Report I)

Rev. Nancy Marroquin, chair, presented on behalf of the committee. She directed the body to Report I which shows the progression of new church developments. She invited the Rev. Karla Lara Maldonado to speak about the work she has been doing in the Weslaco area.

Rev. Albert Kissling, Corresponding Member, challenged the body to sponsor refugee families in our congregations.

John Knox Ranch (Report J)

Andy Watson presented on behalf of John Knox Ranch and its steering committee. He shared a slide show from the first week at summer camp. 540 campers have been registered for camp so far. They received a donation that has paid off the loan for the new dining room.

Synod of the Sun

RE Denise Haley, Synod Commissioner, presented a report. She referred the body to the flyers from the Synod in the packet. August 25th is Synod Sunday.

Poor People's Campaign: Moral Witness Wednesday

Rev. Meagan Ludwig shared her experiences as part of the Moral Witness Wednesday event in Washington D.C. on June 12.

Committee on Representation and Participation

CP Kris Bair, co-chair, presented the report.. The committee nominates Rev. Rachael Huntley to serve in the class of 2020 for the Church Development and Evangelism Committee. **Motion approved.**

This summer the committee will begin to work on the next class to nominate. She encouraged the body to help with finding the volunteers to serve on presbytery committees. The nominations form is available on the presbytery website.

Stated Clerk's Report (Report K)

Rev. Tricia Tedrow, Stated Clerk, presented the report. She reported that the offering for John Knox Ranch scholarships totaled \$2,179.36.

She pointed the body to the 2018 statistical report for Mission Presbytery. She also reported that the General Council has approved standing rules for submitting overtures for the General Assembly. The rules will be posted on the Presbytery meetings page of the website in July. There is guidance for overtures coming from sessions, commissioner resolutions and information about overture advocates.

Rev. Tricia Tedrow reported that San Gabriel Presbyterian Church, Georgetown recently held a congregational meeting to approve changes in their by-laws that would move them from a fiscal calendar to a January calendar for ordered ministries. In order to accomplish this with a smooth transition, the congregation requests a waiver that would extend the terms for the elder and deacons, classes of 2019, 2020 and 2021 for six months. Tricia **moved** that Mission Presbytery approve a wavier, per G-2.0404 on the terms of service for the ruling elders and deacons, classes of 2019, 2020 and 2021, of San Gabriel Presbyterian Church extending them each for six months. Second. **Motion carried.**

The Stated Clerk's office received a request from the Synod of the Sun to vote on the following changes to the Synod's by-laws. She **moved** that Mission Presbytery approve the change to 3.1.2 of the Synod by-laws to read, "Six commissioners (three ruling elders and three teaching elders from six different presbyteries) shall be elected as at-large commissioners to represent racial-ethnic constituencies. The Coordinating Team, serving as the nominating committee, shall make

recommendations for at-large commissioners at the Fall Stated meeting. At-large commissioners are elected by the Assembly." Second. **Motion carried.**
